Dear Ms. Smith and Ms. Patten,

I have been retained to represent OZN Web, LLC in regards to your correspondence dated July 8, 2014. Your letter accuses my client of deceptive advertising in regards to a product produced by Vapex, LLC. However, it appears your research has failed to discern that my client and Vapex are entirely separate entities with no common ownership. *See attached Exhibit A.*


OZN Web contracts with other companies to host and/or direct web traffic to their websites. OZN Web was contracted by Vapex to market its website. OZN Web is in no way responsible for nor does it have control over the content of the sites it marketed for Vapex. As such, OZN Web is not responsible for the content of the sites or any deceptive advertising therein.

Your letter referenced several domains you claimed contained deceptive advertising. However, only two of these domains was owned by OZN Web, VaperXS.com, and TriVaper.com. Both of these domains are no longer active and has not been active since January 20th, 2014. *See attached Exhibit B.* The remaining domains are owned by other corporations only some of which OZN Web marketed. Similar to the relationship with Vapex, OZN Web was in no way responsible for the content of those sites which it marketed. Additionally, OZN Web is no longer marketing for Vapex or any of the other corporations whose domains were listed in your letter. OZN Web's relationships with all of these companies ceased no later than February, 2014. Any further advertising done by Vapex or any of the other companies since is not related to OZN Web in any way.

While it is understood how the confusion regarding this matter occurred, please be advised that as OZN Web is not and has never been responsible for the advertising produced by Vapex you allege to be deceptive. OZN Web has always endeavored to ensure it remains responsible and ethically conscientious in its advertising practices. It also appreciates the work your organizations does to ensure the same with other companies.

Please confirm you received this correspondence and will not be pursuing further action against OZN Web. Should you have any further questions or concerns, please feel free to contact me directly.

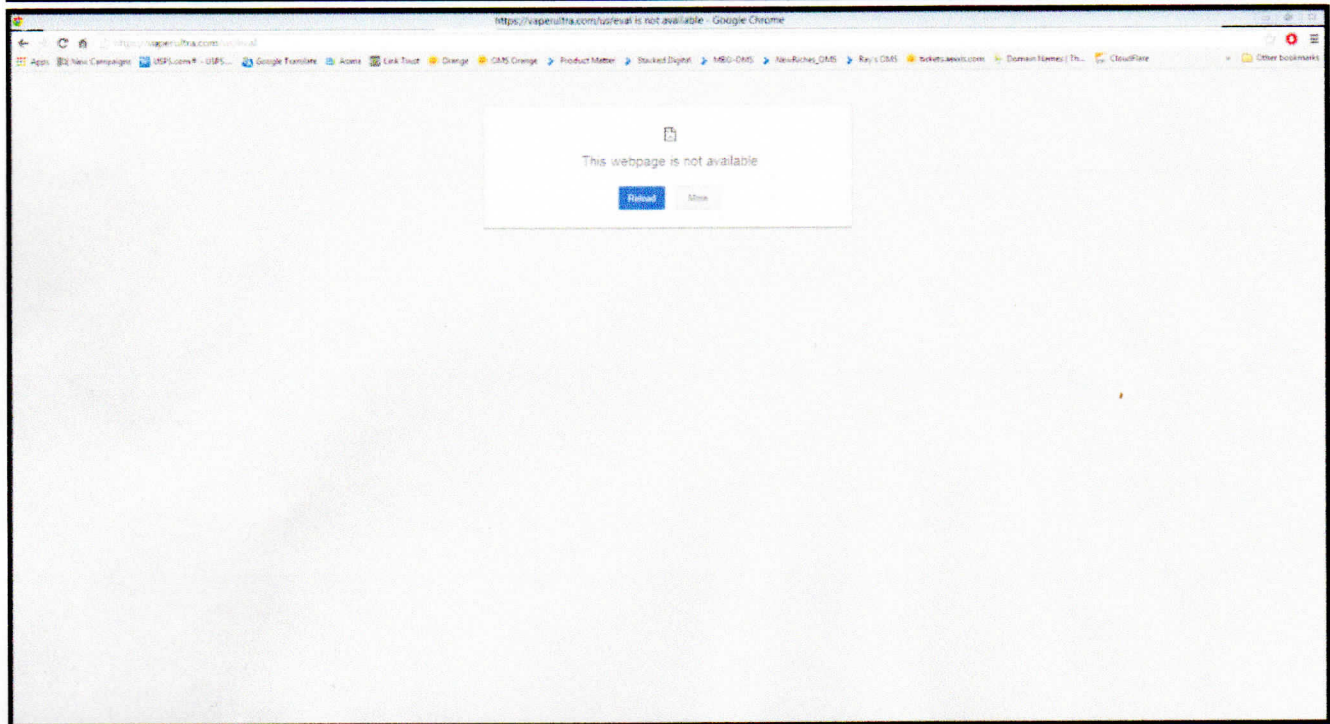
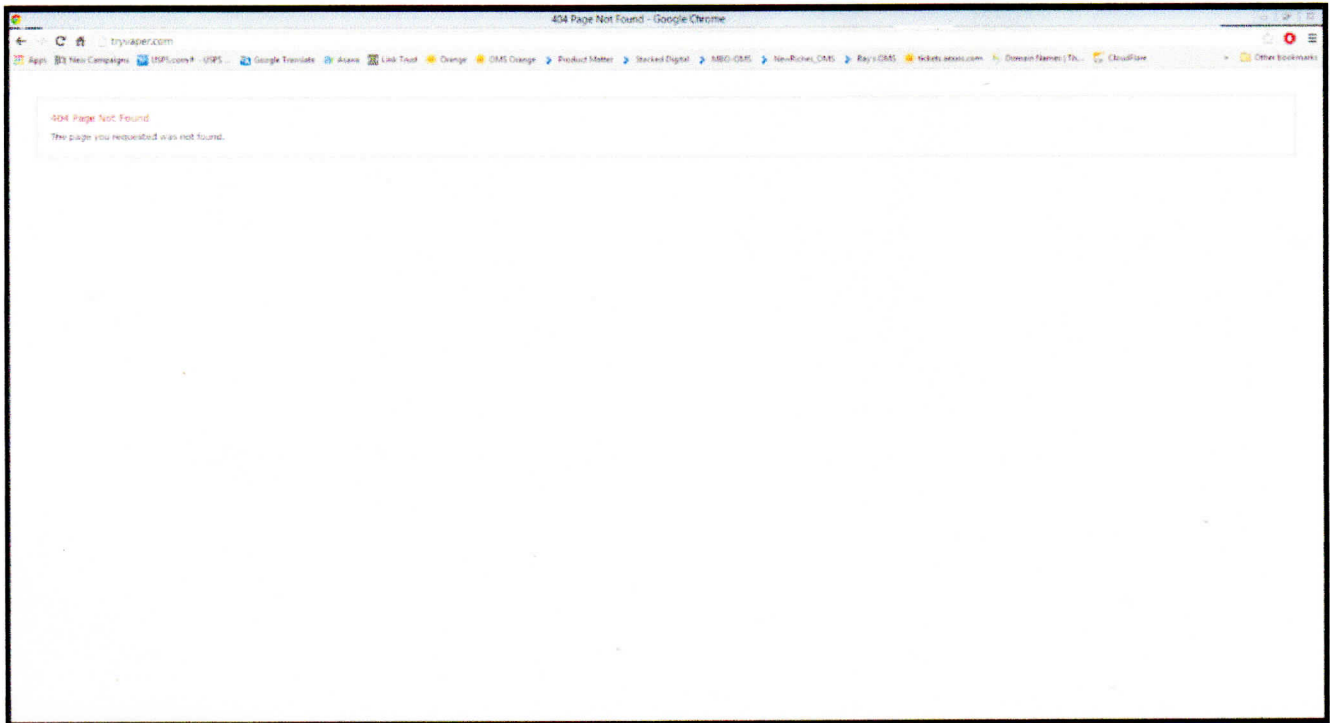

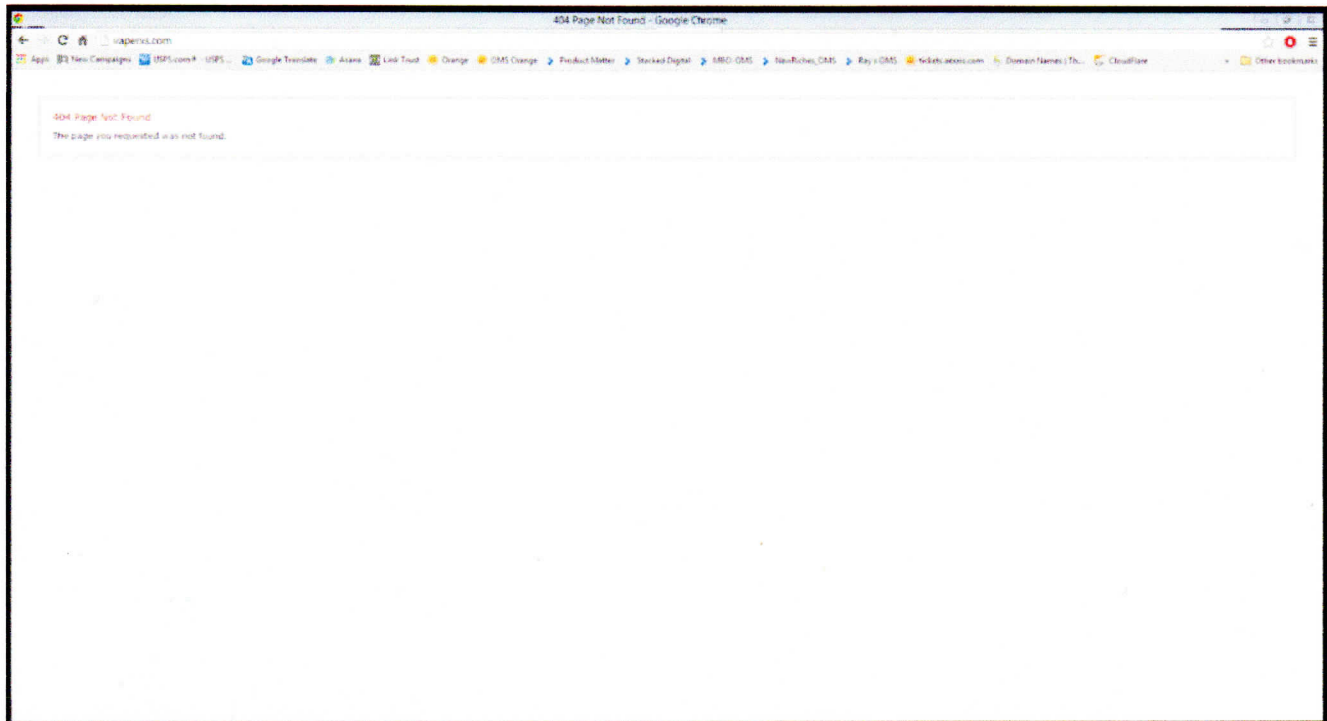
