INFORMATION

The United States Attorney charges:

COUNT 1

- 1. At all times material to this Information, the defendant, MICHELLE MYRTER, was a responsible corporate officer of International Packing, LLC and Universal Cheese and Drying, Inc., and had the responsibility and authority to prevent the commission of criminal violations by International Packing, LLC and Universal Cheese and Drying, Inc. or to promptly correct the criminal violations being committed by International Packing, LLC and Universal Cheese and Drying, Inc.
- 2. From in and around January 2010, and continuing thereafter until in and around January 2013, in the Western District of Pennsylvania and elsewhere, International Packing, LLC and Universal Cheese and Drying, Inc., aided and abetted by MICHELLE MYRTER, caused the introduction and delivery into interstate commerce of food products that were misbranded and adulterated, namely Parmesan and Romano cheese products which

were falsely labeled as one hundred percent real cheese, when in fact, the cheese products did not meet the standards of identity promulgated by the Food and Drug Administration for real cheese and which products also contained other ingredients which were not identified on the products' labeling.

In violation of Title 21, United States Code, Sections 331(a), 333(a)(1) and Title 18, United States Code, Section 2(a).
