1 This matter came on for hearing on September 12, 2016, at 9:00 a.m. in
2 Courtroom 850 of the above-entitled court regarding Plaintiffs' Motion for award of
3 Attorneys' Fees and Costs, and Class Representative Enhancement. After duly
4 considering all papers filed and proceeding had herein, and otherwise being fully
5 informed, and good cause appearing therefore,

including the further briefings by PlainClass Counsel and Objector,

6 **IT IS HEREBY ORDERED, ADJUDGED AND DECLARED THAT:**

7 The Motion for Attorneys' Fees and Costs, and Class Representatives'
8 Enhancement is GRANTED.

9 The Court finds that good cause exists for the granting of the Motion in that the
10 settlement is fair, reasonable, and adequate.

11 Plaintiffs' counsel are awarded attorney fees in the total sum of \$1,462,500.00,
12 plus reimbursement of costs in the total sum of ~~\$75,000.00~~ ^{\$62,425} of which is to be
13 applied towards additional administrative costs, and paid to KCC).

14 In addition to the sums paid to the class members, the Court also approves the
15 payment of an additional litigation enhancement of ~~\$7,500.00~~ ^{\$1,000.00} to Plaintiff STEVEN
16 RUSSELL, and ~~\$7,500.00~~ ^{\$1,000.00} to Plaintiff DONNA CAFFEY.

17 This Court shall maintain continuing jurisdiction over these settlement
18 proceedings to assure the effectuation thereof for the benefit of the Settlement Class.
