26 Pursuant to this Court’s Order dated December 19, 2018 (Dkt No. 115),
27 plaintiffs YAN GUO and JU JIN GUO (“Plaintiffs”) and defendants KYÄNI, INC.

1 (“Kyäni”), MICHAEL BRESHEARS, and KIRK HANSEN (collectively
2 “Defendants”), hereby submit this Joint Status Report.

3 On December 6, 2018, the parties filed status reports informing this Court
4 that the District Court of the Seventh Judicial District of Idaho in Bonneville
5 County (the “Idaho State Court”) had entered an order granting Defendants’ Motion
6 to Compel Arbitration (the “Idaho State Court Order”). *See*, Dkt. Nos. 113, 114.
7 Defendants provided with their status report a copy of the Idaho State Court Order.
8 *See*, Dkt. No. 113-1.

9 In this Court’s December 19, 2018 Order Continuing Stay and Setting Date
10 for Further Report (Dkt No. 115), the Court ordered the parties to “file a joint report
11 on January 22, 2019 or within 10 days of the filing of an appeal of the December 4,
12 2018 decision of Idaho State Court . . . or the expiration of the time for taking an
13 appeal.”

14 Pursuant to that order, the parties hereby report to the Court that, on January
15 4, 2019, Plaintiffs filed in the Idaho State Court a Notice of Appeal of the Idaho
16 State Court Order.
